**Comments:** With the long-term trend towards accrual accounting in the public sector, this

metadata item will ultimately become significant for public sector establishments. Public sector establishments in some states have adopted modified accrual accounting identifying depreciation only, before reaching full accrual accounting. Depreciation is now reported for most public sector establishments and should be

reported as a separate recurrent expenditure.

Depreciation should be identified separately from other recurrent expenditure

categories.
