**Scope:** This is the set of definitions of data originally created for collection by Community Nursing organisations.

The Community Nursing Minimum Data Set Australia (CNMDSA) is a body of work carried out by the Australian Council of Community Nursing Services (ACCNS) and Coopers & Lybrand under a project grant from the (then) Commonwealth Department of Health and Family Services. It has been largely overtaken by the Health and Community Care (HACC) minimum data set which contains many of the CNMDSA definitions albeit slightly modified.

The National Health Data Committee agreed to post all data definitions associated with the CNMDSA to the Knowledgebase in order to allow for public comment.

The metadata registry items in this group are sourced from the National Health Data Dictionary for current items and the Knowledgebase for draft items. Many of the data definitions are still in the draft stage, not having been formally endorsed for the NHDD. These draft items have a registration authority of ACCNS as opposed to NHDD items that have a registration authority of NHIMG.
