Context:	Dwellings are the main counting unit in the housing sector. Dwellings are reported for a variety of purposes including number of untenantable or tenantable, and occupied or vacant dwellings. Dwellings may be owned and/or, managed, and/or available for a use by a specific program, including head-leased stock from <u>private</u> and <u>government</u> sources. A dwelling includes a <u>boarding house building</u> and <u>boarding house units</u> .

Guide for use:	<u>Boarding house rooms</u> or beds are not identified as separate dwellings unless they are self-contained. Self-contained rooms are therefore defined as units and are counted as a separate dwelling.
