Collection methods: Recommended question: 'Did the woman smoke at all during the first 20 weeks of pregnancy?', where the first 20 weeks of pregnancy is defined as less than or equal to 19 weeks + 6 days.

To ensure consistency of results, data should be collected after the first 20 weeks of pregnancy.
