# Data element attributes

## Collection and usage attributes

**Guide for use:** For the residential service setting, as a minimum, 24-hour staffed residential services that employ mental health trained staff on-site 24 hours per day and other services with less intensive staffing (but the trained staff on-site for a minimum of 6 hours a day and at least 50 hours per week) should be defined as separate service units. This applies to both government-operated residential services and government-funded residential services operated by non-government organisations. In addition, residential service units should be differentiated by target population. Residential services would be separately identifiable as service units using the [Specialised mental health service—target population group, code N](#) data element. For additional information, please refer to the glossary item [Residential mental health care service](#).

The Residential service unit name should be unique for the service unit in that state/territory. Service unit reporting structures should be identical between all mental health collections (e.g., Mental Health National Minimum Data Sets and the Mental Health National Outcomes and Casemix Collection (NOCC)).
