A child is considered to be actively attending if they attended a preschool program for at least one hour in the reference period or was absent during the reference period due to illness or extended holiday leave but was expected to return.
	Non-instructional times such as recess, tea breaks and lunch breaks should be included if the child was under the supervision of the service provider organisation.
	The hours enrolled may be less than or equal to the maximum number of hours available for children to attend a preschool program, but may exceed the total number of hours children attended the service in the reference period.
Collection methods:	The number of hours of a preschool program that children are enrolled in a preschool program should be collected for each preschool program available at the service. These data should then be aggregated to the service provider level for reporting purposes.
