Dwellings may be owned and/or, managed, and/or available for a use by a specific program, including head-leased stock from <u>private</u> and <u>government</u> sources. A dwelling includes a <u>boarding house building</u> and <u>boarding house units</u> .

#### Collection and usage attributes

Guide for use:	<b>Boarding house rooms</b> or beds are not identified as separate dwellings unless they are self-contained. Self-contained rooms are therefore defined as units and are counted as a separate dwelling.
	For the public rental housing and state owned and managed Indigenous housing data collections, the number of tenancy (rental) units is used as a proxy for counting the number of dwellings.
