See www.ahpra.gov.au for National Board websites.</p> <p>CODE 2 Health</p> <p>Health (Impairment) (s. 5)</p> <p>Physical or mental impairment, disability, condition or disorder (including substance abuse or dependence), that detrimentally affects or is likely to detrimentally affect a registered health practitioner's capacity to safely practise the profession or a student's capacity to undertake clinical training.</p> <p>CODE 3 Performance</p> <p>Unsatisfactory professional performance (s. 5)</p> <p>The knowledge, skill or judgement possessed, or care exercised by, the practitioner in the practice of the health profession in which the practitioner is registered is below the standard reasonably expected for a health practitioner of an equivalent level of training or experience.</p>
