People whose level of study cannot be determined are assumed to have attained below Certificate II and are therefore excluded from the numerator.

Excludes people whose educational attainment is not stated from the numerator and denominator (applicable only to Census data).

The Indigenous undercount in the Census may introduce bias into the results for Indigenous disaggregation, which may affect comparability across states and territories.

Baseline year for NIRA target (Halve the gap in Year 12 or equivalent attainment rates by 2020) is 2008; baseline year for this measure is 2006; target year is 2020.
