Guide for use:	<p>Grants are to be reported at the lowest statistical unit level at which the expenditure occurred (state/territory or region level), and should not be reported at more than one level.</p> <p>For payment to non-government organisations receiving grants for more than one service type, grants should be apportioned to the service type categories based on the specific provisions of the grant.</p> <p>Grants for <i>Staffed residential services</i> (Code 7 in the Service type data element) must exclude any grants reported as expenditure elsewhere, such as residential service unit expenditure, organisational, regional or state level indirect expenditure.</p> <p>Grants not allocatable to specific service types should be reported under other and unspecified services grants to non-government organisations (Code 88 in the Service type data element).</p> <p>Where the exact dollar amount for services is unable to be provided an estimate should be derived from available local information.</p>
