Guide for use:

PBS items are differentiated via a number of characteristics, including:

- the active ingredient of the medicinal or therapeutic product,
- the strength of the medicinal or therapeutic product, often expressed in terms of the weight or liquid concentration of the active ingredient,
- the form of the medicinal or therapeutic product and its manner of administration, e.g. a tablet, a capsule, an oral liquid, an injection etc.,
- the maximum quantity of the medicinal or therapeutic product to be supplied at any one time,
- the number of repeats, i.e. either a 'single supply' prescription that allows no repeats, or a prescription that allows the supply of a number of repeats up to a specific maximum number,
- any other restrictions associated with the use of the medicinal or therapeutic product, e.g. specific clinical criteria that must be met in order for the product to be administered,
- the specific scheme under which the medicinal or therapeutic product is prescribed and/or any associated benefit is administered.

Example (based on information current as at October 2015)

The drug hyoscine butylbromide, used to treat pain and discomfort caused by abdominal cramps, menstrual cramps or other spasmodic activity in the digestive system, is supplied in a pack of 5 x 1 mL ampoules, at a strength of 20 mg/mL, in injectable form.

Under the provisions of the general PBS, the applicable item code is either '5317W' (up to 3 repeats allowed) or '5318X' (no repeats allowed), depending on the clinical need of the patient as determined by the prescriber. Under these item codes, a maximum of 6 packs can be supplied at any one time.

The same item, supplied under the Prescriber Bag provisions of the PBS, is item code '3473T'. A maximum of 1 pack can be supplied at any one time.

If supplied under the provisions of the Repatriation Pharmaceutical Benefits Scheme (RPBS), the same item is item code '4279F', with no repeats allowed. A maximum of 1 pack can be supplied at any one time.
