If fees are charged on a per day, per term or per year basis, the pro-rata equivalent weekly fee should be derived by taking into account the days per week, weeks per term and/or weeks per year the early childhood education program operates.

**Collection methods:** The standard tuition fee schedule amount for an early childhood education program should be collected for each early childhood education program available at the service.

Jurisdictions which adopt a two week reference period are required to derive their data to a representative reference week
