## Collection and usage attributes

**Guide for use:** The Pregnancy status cluster comprises two data elements that allow a female's pregnancy history to be determined.

This is achieved by the combination of the two data elements: [Female—ever been pregnant indicator, prisoner health yes/no/unknown code N](#) and [Female—age at first pregnancy, total years N\[N\]](#).

The Pregnancy status cluster defines the following information:

N/A is not applicable.

**Collection methods:** Information on a prison entrant's pregnancy history is collected at the reception assessment on the National Prisoner Health Data Collection Prison Entrants form.
