The rates for a single year use single year data for the numerator, and the average of 3 years (with the reference year as the middle year) for the denominator.

A system error affected the reporting of WA Aboriginal and Torres Strait Islander death registrations for 2007, 2008 and 2009 which affected the Western Australian and national death rates reported for the 2011 and 2012 Council of Australian Governments' (COAG) Reform Council reports. These data were revised for 2013 reporting.
