The synonymous name APP_DELIVERY_TYPE_CODE is used for local reporting.

The nationally reported data element has the synonymous name SERVICE_DELIVERY_MODE.

Although this data element is recorded in the NAPAAWL DC at the appointment level, it is reported nationally at the service event level.

The NAPAAWL DC gathers all activity information at both the referral and the appointment level and uses this to ascertain non-admitted patient waiting times and service events. Only the activity that meets the definition of a [non-admitted patient service event](#) will be reported nationally.
