Guide for use:	<p>Each patient attending a group session is counted as a non-admitted patient service event, providing that the session included the provision of therapeutic/clinical advice for each patient and that this was recorded using a dated entry in each patient's medical record.</p> <p>Family members are only counted as attending a group session if they are participating in the non-admitted patient service event as a patient in their own right.</p> <p>Each patient attending a group session is counted as one non-admitted patient service event, regardless of the number of health care providers present.</p>
Comments:	<p>Required to adequately describe the services provided to non-admitted patients.</p> <p>The resources required to provide services to groups of patients are different from those required to provide services to an equivalent number of individuals. Hence services to groups of non-admitted patients should be counted separately from services to individuals.</p>
