Family members are only counted as attending a group session if they are participating in the non-admitted patient service event as a patient in their own

right.

Each patient attending a group session is counted as one non-admitted patient

service event, regardless of the number of health care providers present.

Comments: Required to adequately describe the services provided to non-admitted patients.

The resources required to provide services to groups of patients are different from those required to provide services to an equivalent number of individuals. Hence services to groups of non-admitted patients should be counted separately from

services to individuals.
