Scope: The Public Rental Housing (PH) data set specification defines information about public rental housing tenancies covered by the National Affordable Housing Agreement (NAHA). Included are [households](#) residing in public rental housing dwellings where the dwelling is either:

- owned by the state/territory housing authority; or
- [head-leased from private market](#) or other housing program areas and managed by the state/territory housing authority for provision of public housing.

The PH data set specification excludes dwellings:

- owned but not administered by the state/territory housing authority (for example, dwellings leased to other program areas, such as community housing or crisis and emergency accommodation programs)
- no longer under the administration of the state/territory housing authority at 30 June of the reference period (including dwellings demolished, sold or otherwise disposed of); and
- not yet available to the state/territory housing authority at 30 June of the reference period (including those still under construction or being purchased).

Collection methods: *National reporting arrangements*

State and territory housing authorities provide the data to the Australian Institute of Health and Welfare (AIHW) for national collation on an annual basis.

Comments:
