<b>Guide for use:</b>	For this file a person is a child or young person aged less than 18 years. This includes unborn children in jurisdictions where they are covered under the child protection legislation.
<b>Collection methods:</b>	Client attributes which may be reported differently over time, such as Indigenous status and disability status, should be reported as at the end of the reference period.

	When an estimate is required, all known fields should be entered (e.g. if only year is known use 01/01/YYYY, if year and month are known use 01/MM/YYYY).		
	If the date is not known and cannot be estimated, record as 01/01/1900.
