	 be shaped around the health needs of individual patients, their families and communities; focus on the prevention of disease and injury and the maintenance of health, not simply the treatment of illness; support an integrated approach to the promotion of healthy lifestyles, prevention of illness and injury, and diagnosis and treatment of illness across the continuum of care; and provide all Australians with timely access to quality health services based on their needs, not ability to pay, regardless of where they live in the country. The objective of the Agreement is: 'Through this Agreement, the Parties commit to improve health outcomes for all Australians and ensure the sustainability of the Australian health system' (clause 12).
