The scope excludes:

- all care to admitted patients, including same day admitted patient care delivered by ambulatory mental health care service units
- 'in-reach' mental health service contacts, that is, service contacts provided to patients admitted to admitted patient mental health care services or residential mental health services
- support services that are not specialised mental health care services (see <u>Specialised mental health service</u>) and services provided by non-government organisations.

Excluded from the CMHC NMDS scope is all activity reported to:

- the Admitted patient care NMDS
- the Residential mental health care NMDS.
