- has attended an early childhood education program for at least one hour during the reference period (including attended an early childhood education program online or remotely due to COVID-19 impacts) **OR**
- was absent during the reference period due to illness or extended holiday leave, or due to COVID-19 impacts, but was expected to return.

CODE 2 No

Record if the child:

- has been offered a place but has not formally enrolled or registered in an early childhood education program **OR**
- was not enrolled (i.e. has not been offered a place and formally enrolled or registered) in an early childhood education program **OR**
- was absent during the reference period and not expected to return to the early childhood education program **OR**
- has left the service (e.g. has ceased education or changed services), or has been absent without explanation for four continuous weeks (excluding school vacations) prior to the reference period.
