

#### CODE 2 No

#### Record if the child:

- has been offered a place but has not formally enrolled or registered in an early childhood education program OR
- · was not enrolled (i.e. has not been offered a place and formally enrolled or registered) in an early childhood education program OR
- · was absent during the reference period and not expected to return to the early childhood education program OR
- has left the service (e.g. has ceased education or changed services), or has been absent without explanation for four continuous weeks (excluding school vacations) prior to the reference period.
