Funding received by states or territories through the National Partnership Agreement on Early Childhood Education, the National Partnership Agreement on Universal Access to Early Childhood Education or the National Partnership Agreement on Universal Access to Early Childhood Education—2015 should be **included** under state or territory funding.

<u>Australian Government funding refers only to funding</u> for Child Care Benefit (CCB)-approved services that provide an early childhood education program. These are predominantly Centre Based Day Care services that also provide an early childhood education program.

Funding of services primarily for capital works should be **excluded**.
