<b>Rationale:</b>	For Indigenous Australians with type 2 diabetes, monitoring blood pressure can help assure appropriate medical care to lower the risk of macrovascular (stroke, heart attack and heart failure) and microvascular (kidney disease, eye disease and peripheral neuropathy) complications.
